We outline below the information we gather and use. This information will only be used lawfully. We update this Policy from time to time and we reserve the right to edit, amend or revise this website at any time.

Information we collect

In running and maintaining our website we may collect and process the following data about you:

Details of your visits such as pages viewed and resources accessed. Such information includes traffic data, location data and other communication data.

Information you provide when you communicate with us by any means such as email addresses.

Use of cookies

We may collect information about your computer, including your IP address, operating system and browser type, for system administration and in order to create reports. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

The only cookies in use on our site are for Google Analytics. Google Analytics is a web analytics tool which helps website owners understand how visitors engage with their website. Google Analytics customers can view a variety of reports about how visitors interact with their website so that they can improve it.

Like many services, Google Analytics uses first-party cookies to track visitor interactions as in our case, where they are used to collect information about how visitors use our site. We then use the information to compile reports and to help us improve our site.

Cookies contain information that is transferred to your computer's hard drive. These cookies are used to store information, such as the time that the current visit occurred, whether the visitor has been to the site before and what site referred the visitor to the web page.

Storing your personal data

Unfortunately the sending of information via the internet is not totally secure and on occasion such information can be intercepted. We cannot guarantee the security of data you choose to send us electronically and the sending of such information is entirely at your own risk.

Information you provide to us is stored on local PCs, laptops and portable devices held at our offices. Our devices are password protected. Information provided during a web build and web updates will be shared with our website designers as outlined in our terms and conditions of trading at the time of signing an engagement contract with us.
